2.0 Cut of date:

2.1 Cut of date of eligibility for candidates for 30 % LDCE is 01.01.2023. (As per Railway Board's letter No. E(GP)2022/2/4 dated 14.12.2023).

3.0 Updates Notice on RCF Website

3.1 All updates Notice etc will be uploaded on RCF website, candidates are requested to regularly check https://rcf.indianrailways.gov.in (Staff Comer → Gazetted Section).

4.0 Conditions of Eligibility:

4.1 In terms of Railway Boards letter No. E(GP)99/2/22 dated 29.03.2010, employees working in Level-6 of pay matrix (old scale: PB-2 (₹ 9300-34800)GP ₹ 4200) and above with 05 years of non fortuitous service as on 01.01.2023 i.e. the date of commencement of vacancy period will be eligible.



5.0 Categories of Eligibility.

- 5.1 All staff of Stores Department of RCF, Kapurthala & at TKJ holding Gr. 'C' posts in Level-6 (GP 4200) and above with 05 years of non fortuitous service in the grade are eligible to apply for the selection.
- Instructions have been issued under Board's letter No. E[NG]I-2006/PM1/5 dated 21.03.2006 [RBE No. 34/2006], whereby, in partial modification of instructions issued under Board's letter No. E[NG]I-96/PM4/14 dated 17.04.1997, it has been decided that in case of persons transferred on request basis to a new unit in the same category of posts, and assigned bottom seniority therein, the service rendered by them in the previous unit may be reckoned for determining their eligibility wherever a minimum length of service is prescribed as a condition, for promotion in the new unit, subject to the condition that the length of service which is so allowed to be counted does not exceed the length of service of their immediate senior in the new unit. If the junior is eligible, senior employee will not be eligible automatically unless he is also fulfilling the condition of eligibility of 05 yrs non-fortuitous service in LDCE.
- 5.3 As per Railway Board's letter No. E(NG)/1/93/PM1/4 dt. 18.01.1993, "The time spent by a Railway Servant under training immediately before appointment to service is to be counted as service for the purpose of appearing in LDCE for promotion to Group 'B'."

6.0 Written Examination:

- 6.1 In terms of Railway Board's letter No. E(GP)2022/2/4 dated 14.03.2024, the computer based test (CBT) shall be conducted by DG/NAIR, center to be informed at later stage to eligible candidates.
- 6.2 Written examination for the above selection consists of One paper which will be conducted by DG/NAIR. NO SUPPLEMENTARY EXAMINATION will be held for the absentees as per extant Board's orders.

7.0 Examination Pattern.

- 7.1 The selection consists of a Written Test (Computer Based Test) followed by viva-voice for those qualifying in written Test. LDCE will be one stage only and will comprise of only 1 paper
- 7.2 As per Railway Board's letter No.E(GP)2022/2/4 dated 06.09.2022, marks for optional questions is detailed as under.
