**1.0 Selection Proposal :**

1.1 A selection for promotion of Group 'C' staff to Group 'B' in Level 8 of Pay Matrix in Mechanical Department of RCF against 70% quota is proposed to be held for filling up vacancies as per selection procedure laid down in Railway Board letter No. E(GP)88/2/111 dated 20.08.1991, No. E(GP)2018/2/31 dated 19.03.2019 (RBE No. 53/2019), Master Circular 68 dated 08.07.2019, No. E(GP)2005/2/69 dated 16.01.2020 (RBE No. 05/2020), E(GP)2022/2/4 dated 28.06.2022 and other policy guidelines issued by Railway Board from time to time.

The number of vacancies assessed for selection Regular -70% and LDCE-30% are indicated below along with reserved vacancies.

## **2.0 Reservation to persons with Benchmark Disabilities (PwBDs).**

2.1 Reservation to persons with Benchmark Disabilities (PwBDs) as per details mentioned below as per Railway Board's letter No. E(GP)2022/2/ 20 dated 18.08.2022 (RBE No. 97/2022).

2.2 Successful PwBD candidates in CBT will be subject to medical examination by Railway medical authority prior to viva-voce and only those candidates conforming medical standards as laid down in the medical manual (IRMM) & other extent provisions as the case may be will be eligible for Viva-voce / empanelment.

2.3 In terms of DoPT's letter No. 36012/1/2020-Estt.(Res-II) dated 17.05.2022 circulated vide Railway Board's letter No. E(GP)2022/2/2022 dated 18.08.2022 point no. 10.1 for PwBDs there will be separate roster / register for Gr. B posts and as per point no. 13.1 due to non-availability of candidates even in extended zone, the vacancy of PwBD roster will not be filled and will be carried forward to the subsequent year.

## **3.0 Eligibility list of Candidates:**

3.1 List of eligible candidates for appearing in the selection as per Railway Bd's letter no. E(GP)2007/2/25 dated 30.03.2007 is prepared and attached as Annexure 'A', on the basis of their seniority.

3.2 The staff listed in Annexure 'A' eligible to appear in the selection and may be advised to keep themselves in readiness to appear in the written examination.

3.3 The Zone of consideration for SC/ST candidates to be called for appearing in the selection for filling up Group 'B' Posts is done as per Railway Board's letter No. E(GP)2002/2/49-Pt dated 17.03.2008.



#### **4.0 Acknowledgment & Willingness/Unwillingness of Eligible Candidates:**

- 4.1 The controlling Officer should ensure that copy of this notification is delivered to each of the candidates listed in the enclosed Annexure 'A' and their acknowledgment obtained in Annexure 'C' which should be sent to SPO-I, upto 20.01.2024.
- 4.2 Candidates who are not willing to give the above said examination are required to submit their unwillingness and forward the same to SPO-I, upto 20.01.2024.

#### **5.0. Submission of Applications:**

- 5.1 It should be ensured that wide publicity is given to this notification so that the willing and eligible staff may submit their application in time. It is personal responsibility of the Controlling officers of the units that the notification reaches to all the eligible employees in time.
- 5.2 Applications in the prescribed Performa (Annexure- 'B') are invited from the willing staff who fulfill the conditions of eligibility and it should be forwarded to this office latest by **20.01.2024** under the clear signature of controlling officer on the Performa as Annexure-B
- 5.3 Applicants should fill all the columns in the prescribed Performa, signature of applicant and date is compulsory. Application without signature & date is liable to be rejected.
- 5.4 Incomplete application or application submitted after the due date will not be entertained. No application or advance copy thereof should be sent to this office directly.

#### **6. 0 Representations as to Objections :**

- 6.1. If any Employees has any objections against any point of this notification, the employee may give his representation to SPO-I, RCF/KXH through proper channel only latest by 20.01.2024 after which no representation will be entertained.

#### **7.0 PROCEDURE TO NOTIFY ALL ELIGIBLE EMPLOYEES**

- 7.1 If any of the employees included in the list has been transferred on deputation with other departments/units and he/she is a lien holder then he/she must be informed well in time by the officer in-charge of the department concerned from where he proceeded on deputation and his willingness/unwillingness obtained and sent to this office (SPO-I, RCF/KXH) well in time. Controlling officer of the department concerned will also be responsible to ensure that the notification is brought to the notice of all employees in the respective organization working under him and it may be ensured that the notification has been got noted by all the eligible employees working in their respective organization or belonging to them. This shall be applicable in case of eligible employees on sick/leave also. Confirmation of this may be sent by them to this office (SPO-I, RCF/KXH) for record.



## 8.0 Examination Pattern.

- 8.1 In terms of Railway Board's letter No. E(GP)/2022/2/4 dated 28.06.2022, the Computer Based Test (CBT) shall be conducted by DG/NAIR, center will be intimated at later stage.
- 8.2 The selection consists of a Written Test followed by viva-voice for those qualifying in written Test.
- 8.3 With the introduction of Multiple choice objective type questions, the following pattern of examination has been adopted for 70 % selections to be conducted through centralized CBT :

- 8.4 One mark will be allotted for every correct answer. There shall be negative marking for incorrect answers and 1/3<sup>rd</sup> of marks allotted for each question will be deducted for every wrong answer. (Railway Board's letter No. E(GP)2018/2/31 dated 19.03.2019).

- 8.7 Optional questions on Official language policy and official language rules shall be included in terms of provision contained in para 204.3 of IREM Vol.I

9.2 Venue: Tentatively New Delhi, Center will be notified later.

### **12.0 Examination Hall :**


