0. Introduction

This specification covers scope of work as "Supply& fitment of complete furnishing of LHB EOG Inspection Carriage (Administrative)" by the firm on Turnkey basis & eligibility criteria, general requirements & other guidelines regarding execution of work.

1. Objective of this document

This document contains the techno-commercial requirements for enabling a tender and contract and post contract activities for the items included in the scope.

This document is to be read along with the other tender documents i.e.

- 1. Notice Inviting Tender
- 2. RCF Bid Document
- 3. GCC or other standard conditions as applicable.

2. Scope of the specification

This document is a purchase specification for enabling purchase and installation of interior furnishing items for LHB EOG Inspection Carriage (Administrative). The document specifies the requirements for eligibility criteria, scope of supply, quality assurance requirements, prototype approval and inspection requirements, as supplied requirements, project schedule, payment milestones and guarantee warrantee.

These have been framed keeping in view the lifecycle requirements of the items to be supplied.

This document is planned to be used as part of the tender specifications for the purchase of Furnishing item kits and turnkey interior furnishing for manufacture of LHB EOG Inspection Carriage (Administrative).

5. Pre-requisites for eligibility for bulk (regular) and development orders:

The following eligibility criteria shall be followed for evaluation of offers. These are grouped into technical and financial requirements.

Note: The pre-requisites provided here are to be used as default requirements. These may be overruled by the eligibility requirements prescribed while processing the purchase.

5.1. Eligibility for Bulk / Regular Purchase

The following clauses list the eligibility for bulk (regular) purchase.

The following shall be the technical eligibility requirements to qualify for bulk purchase.

Note: If supporting documents for credentials as per the eligibility criteria are not enclosed, then RCF shall use its own available records or reject the bid.

5.1.1.1. Requisite Quality certification

The Bidder shall have ISO 9001:2015 certification valid on date of bid closing. Copies of the certification shall be provided.

5.1.1.2. Proven capability and capacity

The bidder should have successfully completed turnkey furnishing of either 20% of the tendered quantity or 25 Nos. of air-conditioned railway coaches, whichever is lower, of gauge 610mm and above, and with axle load of 5 tonnes and above for any public passenger railways of the world, in a single order within period of previous three financial years and current financial years as on the date of bid closing. Turnkey means single work including panelling, seats & berths, AC ducting, roofing, flooring, toilets and electrical wiring and fittings.

Successful completion shall mean completion of work as per the contract scope including quality checks. In case of Indian Railway, completion certificate by executive department of purchasing unit and in case of entities other than Indian Railway, certificate from purchaser shall be considered for successful completion.

5.1.1.3. Financial Eligibility

Firm's total gross revenue/turnover within a period of previous three Financial Years preceding the bid closing date must be minimum 100 % of the estimated tender value.

Copies of Audited Profit and Loss account and balance sheet should be provided. Where the same is not available for the latest financial year, certificate of statutory Auditor stating that the same is not available should be enclosed. In such case, the bidder shall provide audited profit and loss account and balance sheet for 3 years preceding the year for which the audited annual report is not being provided. These financial statements must be certified by a chartered accountant or any statutory auditor.

5.1.1.4. Electrical Contractor License: (This Clause shall be included wherever applicable)

The bidder shall undertake in the bid to submit a valid class "A" Electrical contractor's License as applicable from the concerned statutory authority before start of execution of the work.

The bidder shall provide an undertaking in the bid to submit a formal agreement with suitable Sub-contractor, holding a valid class A" Electrical contractor's license as applicable from the concerned statutory authority, for

executing electrical portion of work. The bidder shall submit a formal agreement duly notarized, legally enforceable in the court of law, between the bidder and sub contractor for the Electrical component of work proposed to be executed by the sub-contractor, before start of execution of work.

5.1.1.5. Performance

Out of the turnkey furnishing completed by the bidders during the last 5 financial years preceding the bid closing date, at least 10 coaches or 8% of tender quantity (rounded off to next whole number), whichever is less must be in successful operation (No pending warranty complaint) for minimum 1 year after commissioning ending 30 days prior to bid closing date.

The assessment shall be made from the entries on the IR warranty Portal. certificate for successful operation will be submitted from User Railway (in case of Indian Railway, the certificate shall be submitted from Head of Quality Unit of the contracting Production Unit).

5.2. Eligibility for Developmental Purchase

There shall be no developmental Order.

Note: Documents to establish eligibility should be submitted by bidder along with the bid.

5.3. In case the bidder is a Consortium / Joint Venture

In case the Bidder is a Consortium/Joint Venture, it shall comply with the following additional requirements:

- 1. Number of members in a Consortium/Joint Venture shall not exceed 4 (Four).
- 2. A firm can be a partner in only one Consortium. Bids submitted by Consortium including the same firm as partners in more than one bid, will be rejected. (This restriction will not apply to sub-contractors for the bought-out items)
- 3. The Bid should contain the required information for each member of the Consortium/Joint Venture.
- 4. Members of the Consortium/Joint Venture shall nominate one member as the "Lead Member".
 - 4.1. Lead Member shall meet 51% of the financial eligibility condition in case of Consortium or shall have minimum 51% shareholding in the Joint Venture.
 - 4.2. The nomination of Lead Member shall be supported by a Power of Attorney, as per the format at Annexure 1&2, signed by all the other members of the Consortium/Joint Venture.
 - 4.3. The lead partner shall be responsible for coordinating the scope of supply / work as detailed in this document. There should be an authorization to this effect evidenced by submission of a power of attorney with bid duly signed by legally authorized signatories of all partners.
 - 4.4. The lead partner shall be authorized to incur liabilities and receive instructions for and on behalf of any and all partners of the Consortium, and the entire execution of the contract, including payment, shall be done exclusively by the lead partner.
 - 4.5. The lead member of Consortium shall be responsible for all financial covenants and bank guarantees.
- 5. Technical Eligibility requirements is to be satisfied by any member of Consortium/Joint Venture having minimum 26% share of financial eligibility in case consortium or 26% shareholding in the Joint Venture.
- 6. Consortium/Joint Venture as whole shall cumulatively/collectively fulfil the 100% Technical Capability as per and 100% Financial Capability.
- 7. The Bid shall include a brief description of the roles and responsibilities of individual members, particularly with reference to financial, technical and defect liability obligations;
- 8. The Lead Member shall carry out works directly under its own supervision and through its own personal.

- 9. Members of the Consortium/Joint Venture shall have entered into a binding Joint Bidding Agreement, substantially in the form specified at Annexure 3, for the purpose of making the Bid.
- 10. A copy of the agreement entered into by the Consortium partners shall be submitted with the bid. Alternatively, a "letter of Intent" (to execute a Consortium agreement, meeting with all specified requirements, in the event of a successful bid) shall be signed by all Consortium partners and submitted with the bid together with a copy of the proposed agreement. Consortium agreement duly signed by all Consortium partners shall form part of the contract agreement. The Consortium agreement should precisely indicate the responsibility of all members of Consortium in respect of planning, design, manufacturing, supply, installation, system integration, commissioning, training and warranty obligations etc. This should not be varied/ modified subsequently without the prior approval of the purchaser. The Consortium agreement should be Registered/Notarized anywhere in India, if the lead partner/Consortium partners are registered in India. For foreign companies, they should be Registered/Notarized as per the laws of their respective country, so as to be legally valid and binding on all partners. (Annexure-3)
- 11. All partners of the Consortium shall be liable jointly and severally for the execution of the contract in accordance with the contract terms.
- 12. Approval for change of constitution of Consortium/Joint Venture shall be at sole discretion of the Authority. The constitution of the Consortium/Joint Venture shall not be allowed to be modified after submission of the Bid by the Consortium/Joint Venture, except when modification becomes inevitable due to Succession laws etc., provided further that there is no change in qualification of minimum eligibility criteria by Consortium/JV. However, the Lead member shall continue to be the Lead Member of the Consortium/Joint Venture. Failure to observe this requirement would render the offer invalid.
- 13. Similarly, after the contract is awarded, the constitution of Consortium/Joint Venture shall not be allowed to be altered during the currency of contract except when modification becomes inevitable due to Succession laws etc., provided further that it does not change the minimum eligibility criteria. Failure to observe this stipulation shall be deemed to be breach of contract with all consequential penal action as per contract condition.

- 2. **Witness Points:** means an identified point in a process where the Contractor must give prior notice to RCF to allow a designated authority of RCF or 3rd party agency duly authorized by RCF, to attend and witness the point in the work process should it choose to do so.

The inspection plan shall be reviewed and agreed jointly by RCF and the contractor.

11. Provisioning of facilities for working

The following shall be the distribution of provisioning of facilities for working during the course of the project.

11.1. Facilities to be provisioned by RCF at RCF/KXH

RCF shall provide the following provisions for enabling the contractor working at RCF premises only.

- 1. RCF shall provide limited space inside covered shed (not enclosed) to the contractor for keeping the material/consumables& tools required for day today work.
- 2. RCF will provide suitable cranes with drivers, as available at RCF/KXH, for loading unloading of furnishing items i.e. FRP modular lavatory.

- 4. Power supply, Compressed Air and water etc. for working at site shall be provided by RCF/KXH.
- 5. Access to toilets and drinking water facilities shall be provided at RCF/KXH.

11.2. Facilities to be provisioned by the contractor

- 1. Contractor shall deploy a site office structure in ISO container(s) to function as site office and site tools and material storage. The site office shall be setup by the contractor and removed and taken away by the contractor at the end of the contract.
 - a. The site office shall be self-contained, however electrical supply shall be provided by RCF at RCF/KXH.

11.3. Safety and performance of tools and equipment of the contractor

12.2. Follow RCF production plan

All shells to be furnished as per production plan of RCF; Supply schedule of each variant will be in staggered manner and will be manufactured and supplied as per schedule of supply advised by Dy.CME/Fur/RCF from time to time.

Planned project schedule is mentioned at Para 9.0. After clearance of first Prototype Coach from quality deptt. or as communicated by Dy.CME/Fur/RCF, supplier will supply furnishing material within one month. 12.3. Safe keep during storage and transit

The contractor shall be responsible for safe transporting and loading/un-loading of supplied products. Adequate measures shall be taken to avoid damage to surface body shell surface during transport/storage.

12.4. RCF right to inspect and audit

RCF shall have the right to take item/assembly supplied by the firm into Audit for checking of parameters as per laid down procedure.

12.5. Handling of changes post approvals

Any changes from approved models, detailed part drawings, BoM, material specifications shall be done via a design approval process and be released for implementation with the approval of CDE/CEDE/RCF.

Any modification arising out of design review process shall be incorporated by the firm in bulk supply without any financial implication.

12.6. Sourcing of raw material and assemblies

13.1. Attention on site
