Sub: Selection for Promotion to Group 'B' Services in M&C Department for the post of ACMT in Level 8 of Pay Matrix.

A selection for promotion from Group "C" to Group "B" service in Pay Matrix Level 8 in M&C Department of RCF is proposed to be held for filling up **01 vacancy**, for the post of Assistant Chemical Metallurgist (ACMT). 1.0 Eligibility list of Candidates:

- 1.1 As per Recruitment Rules, 2011, Group "C" employees working as Chemical & Metallurgical Superintendent in Level-07/ GP Rs.4600/- with two (02) years regular service as on 01.01.2025, are eligible for appearing in the selection.
- 1.2 The staff listed in Annexure 'A' are eligible to appear in the selection, they may be advised to keep themselves in readiness to appear in the written examination.
- 1.3 Candidates from standby list should also keep themselves in readiness for appearing in the examination. However, they will be called for equal to the number of candidates who give their unwillingness mentioned in list 'A' as per rules.

2.0 Acknowledgment & Willingness of Eligible Candidates:

- 2.1 The controlling Officer should ensure that copy of this notification is delivered to each of the candidates listed in the enclosed Annexure 'A' and their acknowledgment obtained in Annexure 'B' which is in the Performa & should be sent to APO-I, Upto **07.07.2025**.
- 2.2 Candidates who are not willing to give the above said examination are required to submit their unwillingness and forward the same to APO-I upto **07.07.2025** on the same Performa i.e. Annexure-B.

3.0. Submission of Applications:


- 3.1 It should be ensured that wide publicity is given to this notification so that the willing and eligible staff may submit their application in time. It is personal responsibility of the Controlling officers of the units that the notification should be reached to all the eligible employees in time.
- 3.2 Applications in the prescribed Performa (Annexure- 'B') are invited from the willing staff who fulfill the conditions of eligibility and it should be forwarded to this office by **07.07.2025 at 16:00 Hrs** under the clear signature of controlling officer on the Performa as Annexure 'B'.
- 3.3 Applicants should fill all the columns in the prescribed Performa, signature of applicant and date is compulsory. Application without signature will be rejected.
- 3.4 Incomplete application or application submitted after the due date will not be entertained. No application or advance copy thereof should be sent to this office directly.

4.0 The Selection Process:

- 4.1. The selection will comprise of written test and a viva-voce. The candidates who qualify in the written examination will have to undergo the prescribed medical examination before being called for viva-voce.
- 4.2 As per Railway Board's letter No.E(GP)2005/2/69 dated 16.07.2019 & 04.12.2023 (RBE No. 134/2023) the written examination shall comprise of one question paper which shall have 100 % objective type multiple choice questions only.

The paper will be of 100 marks & the distribution will be as under :

(There will be total 110 Questions in the written examination (including 10 optional questions related to the official language i.e. Rajbhasha).		



- 4.3 Out of 110 questions, candidates are required to **attempt 100 questions**, 10 questions will be related to official language i.e. Rajbhasha which will be optional.

5.0 Negative Marking:

- 5.1 As per Railway Board's instructions issued vide letter No.E(GP)2018/2/31 dated 19.03.2019, negative marking will be applicable in the written examination. For every wrong answer, 1/3rd of the marks allotted to that question will be deducted
- 5.2 One (01) marks will be given for every correct answer.
- 5.3 No corrections of any type (Viz cutting, ticking another answer, erasing, modifying the answer in any way) no such thing will be permitted.

6.0 Supplementary Examination:

- 6.1 Candidates who fail to appear in the written examination only on medical grounds duly certified by Railway Doctor, will be allowed to appear in the supplementary examination on production of medical certificate issued by Railway Doctor bearing specific remarks that the fact was known to him that the candidate has to appear in the selection. In the absence of medical certificate the candidate will not be allowed to sit in the supplementary examination.

7.0 Date of Examination & Venue:

- 7.1 Date of Examination will be notified later.
- 7.2 Venue: TTC / Rail Coach Factory, Kapurthala.


9.0 Important instructions.
