

## **CCTV SURVEILLANCE SYSTEM FOR 3-PHASE MEMU RAKES**

- 1.0 The Passenger Car Surveillance System shall comprise of an IP based close circuit television (CCTV) system network, surveillance cameras, routers and cables, monitors and other accessories as per RDSO Telecom Directorate Specification no. RDSO/SPN/TC/106/2022 (Version No. 2.1), Amendment no. 1 or Latest.
- 2.0 The Full HD Fixed Dome/Wedge type IP Colour Camera shall have security features which can be deployed meeting all the parameters applicable to cameras with relevant and equivalent safeguards as per Essential Requirement mentioned in Appendix "A" of MeitY Gazette Notification no. CG-DL-E-08032024-252738 dated 7<sup>th</sup> March 2024.

Note: The security testing certification of Cameras to be issued by Standardization Testing and Quality Certification (STQC) Laboratory or any other agency notified by MeitY from time to time.

## 4.0 Scope of Supply:



supplier may visit and physically assess the existing 3-Phase MEMU rakes under manufacture at RCF. Software Development Kit (SDK) or API of all Hardware/ Software shall be shared with the purchaser for testing purposes, as and when required.

**Note:** The system display (HMI) shall automatically switch to platform view when the train stops and shall go back to default mode (saloon view) after the train leave the platform.

## 5.0 Audit and Testing:

The successful Bidder shall ensure the security of entire CCTV system which shall be subjected to Security Audit/Testing as mentioned below:-

"Vulnerability Assessment and penetration Testing (VAPT) for complete system along with Mobile NVR /VRU and associated components, such as PoE switches, Wi-Fi Access Points, GPS, Mobile Communication etc. The testing though STQC lab shall be got done by the firm."
